



# 景順強積金策略計劃 Invesco Strategic MPF Scheme

- 景順強積金策略計劃(「本計劃」)現提供預設投資策略及十二項成分基金，包含以下基金類別：股票基金(包括緊貼指數基金)、債券基金、貨幣市場基金、回報保證基金與混合資產基金。
- 所有於「每月基金便覽」內呈列的資料均屬於成分基金之資料。
- 本計劃之回報保證基金純為投資於美國信安保險有限公司所發出之保險單，美國信安保險有限公司亦為保證人(「保證人」)。閣下於回報保證基金之投資因而須承擔保證人之信用風險。只有(i)出現特定情況而保證人接獲有效申索，或(ii)出現其他情況(如認購章程所載者)，回報保證基金之保證人方會提供資本保證及指定回報保證率。閣下應先細閱認購章程，然後始投資於回報保證基金。有關信用風險、保證特色與保證條件之詳情，請參閱「風險因素」一節及認購章程附錄。

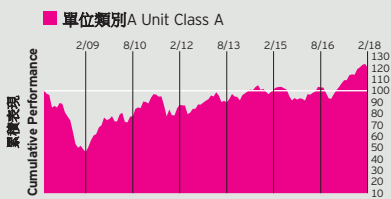

基金評論 Fund Commentary

亞洲（日本除外）股市在2月份下跌，表現與其他主要股票市場一致。事實證明經濟敏感度較低的行業更具抗跌力，而高收益股票則備受打擊，尤其是電訊和房地產股。

印度和台灣股市在2月份回落。在台灣，當地消費穩健和出口強勁，預期當地經濟會持續擴張。東盟市場表現優於亞洲其他地區，當中以泰國表現最好。就行業而言，防守性行業表現優於週期性行業。儘管本月市場波動，但我們認為區內的經濟和企業基本因素沒有改變。

Asia ex-Japan equity markets fell in February, in line with other major equity markets. Less economically sensitive sectors proved to be more resilient, while high-yield stocks were hit hardest, particularly telecoms and real estate.

India and Taiwan markets retreated in February. In Taiwan, we expect their economic expansion to be sustained, supported by steady domestic consumption and resilient exports. The ASEAN markets fared better compared with other parts of Asia, with Thailand being the best performer in the region. On sector basis, defensive sectors outperformed cyclical sectors. Despite the market jitters this month, we believe there is no change to economic and corporate fundamentals in the region.
