## Important Information

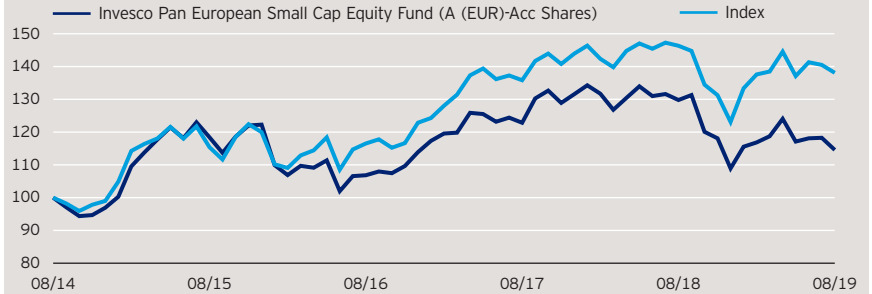
