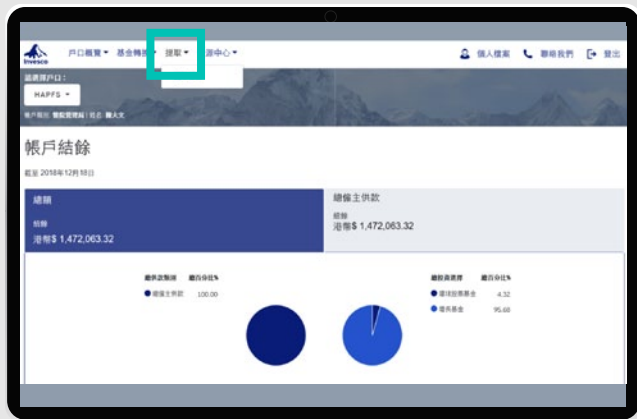

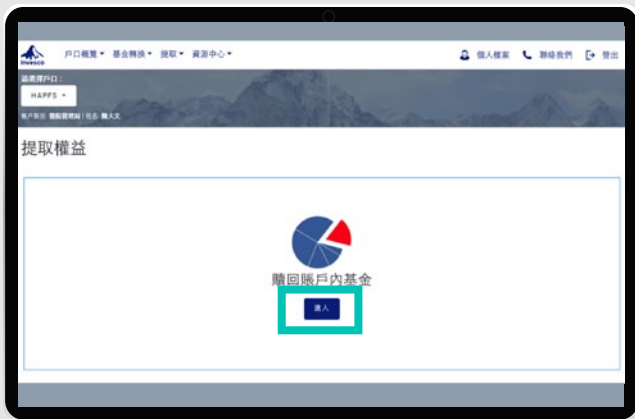

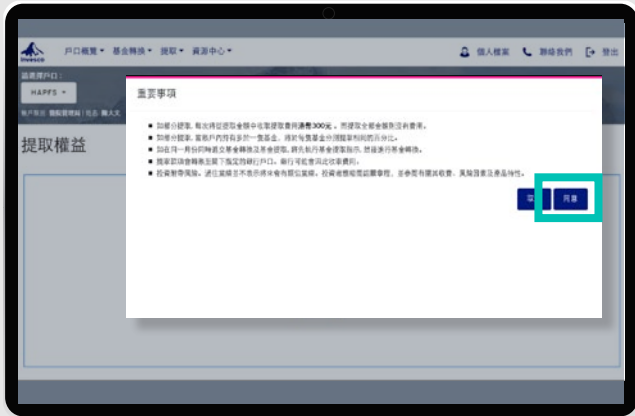

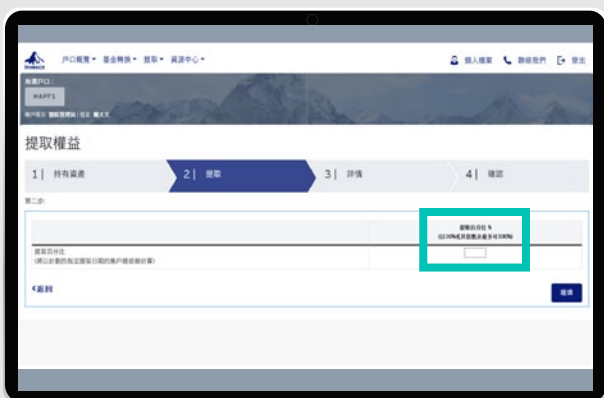
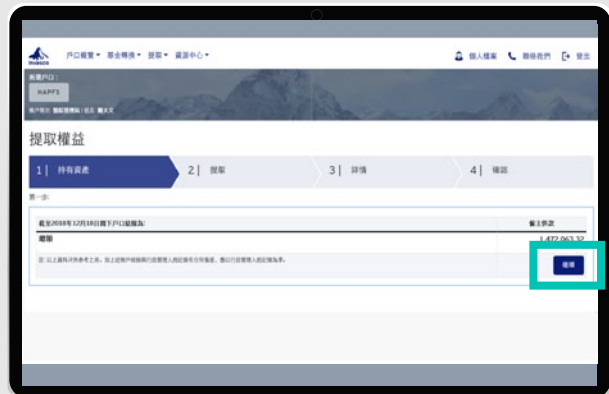
提取權益步驟 Steps to Withdrawal Benefits

- Press “Continue” to withdraw benefits

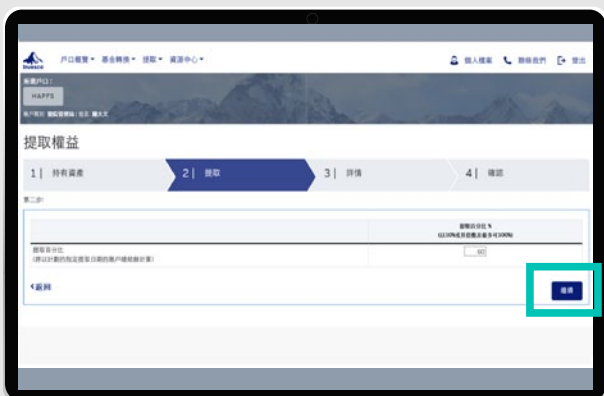


第二步：

Step 2:

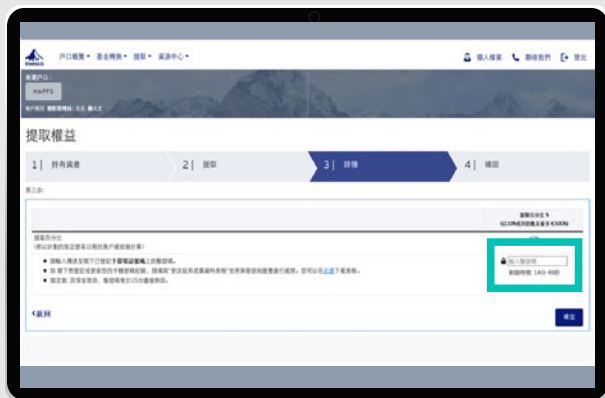
- Input the withdrawal percentage

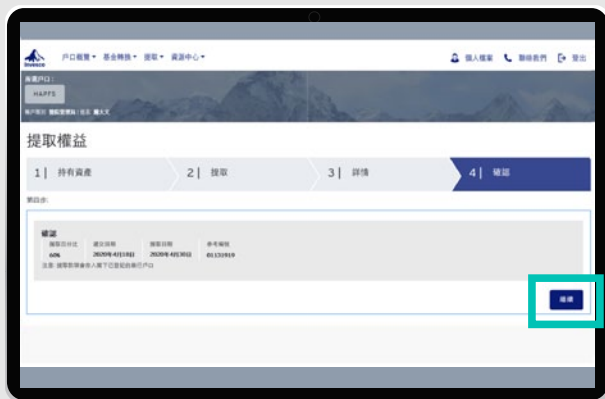


第三步：
