- 景順強積金策略計劃(「本計劃」)現提供預設投資策略及十二項成分基金，包含以下基金類別：股票基金(包括緊貼指數基金)、債券基金、貨幣市場基金、回報保證基金與混合資產基金。
- 所有於「每月基金便覽」內呈列的資料均屬於成分基金之資料。

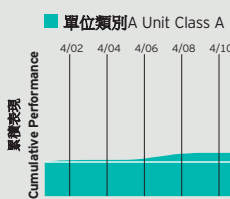

基金評論 Fund Commentary

4月份，地緣政治局勢維持緊張及有關貿易戰的憂慮繼續令市場情緒受壓。美中之間的貿易談判仍面臨重重挑戰。美國數據表現穩健令市場繼續聚焦美國利率正常化速度。但美國以外地區的央行或放緩收緊步伐。歐元區經濟數據表現不甚理想，進而為歐洲央行於短期內結束量寬政策帶來挑戰。鑑於近期英國經濟及通脹數據走軟，因此其提前加息的機率有所減小。10年期美國國庫券息率達3%，並徘徊於近期的高位。國庫券息率錄得上升，曲線平行上移20至22點子。香港政府債券曲線表現遜於美國同類債券，短期債券及10年期債券息率分別上升28點子及22點子。香港金管局於美元兌港元觸及7.85時介入，買進510億港元，推動短期港元利率大幅上升。4月份，香港銀行同業拆息躍升35點子，而倫敦銀行同業拆息僅升5點子，進而推動3個月香港銀行同業拆息／倫敦銀行同業拆息息差收窄33點子。

In April, heightened geopolitical tensions and traded fears continued to weight on market sentiments. The US-China trade negotiations remained challenging. The resilience of US data has kept market fixated the pace of US rate normalization. However, capitulation of central banks tightening expectations outside US. The Eurozone data continue to disappoint and posed challenges for the European Central Bank (ECB) to end the QE anytime soon. Recent softening economic and inflation data in UK lessened chance of early rate hike. 10-Year US Treasury yield reaching 3% and hovering near recent peak. Treasury yields grinded higher with curve parallel shifted upward by 20-22bps. Hong Kong Government bond curve underperformed its US counterparts with short-end bond yields up 28bps and 10-year up 22bps. The Hong Kong Monetary Authority (HKMA) intervene the USDHKD at 7.85. As a result of intervention, HKD51bn has been drained from aggregate balance and short-term HKD rates were squeezed much higher. 3-month HIBOR/LIBOR spreads narrowed 33bps as 3-month LIBOR jumped 35bps in April, while 3-month LIBOR only up 5bps.
