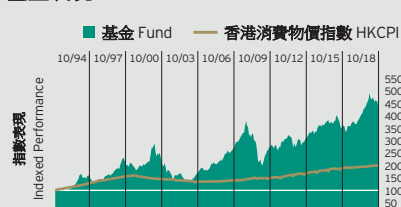

**基金評論 Fund Commentary**

中國離岸市場在10月份錄得負回報，貿易糾紛持續，孳息率上升以及市場擔心經濟增長，都導致主要市場被大幅拋售。香港市場表現與中國一致，均錄得負回報。包括電訊運營商和公用事業公司在內的防禦性股票繼續跑贏大市。隨著科技股被冷落以及而市場越來越擔心中美貿易糾紛，美國股市下跌。鑑於英國脫歐等地緣政治因素以及中美貿易戰持續升級，歐洲股市下挫。由於全球經濟衰退的風險上升以及投資氣氛惡化，日本股市亦大幅下挫。東盟股市下跌幅度較小，而菲律賓和印尼則在區內表現最好。10月份，政府債券表現優於企業債券，投資級別債券表現優於高收益債券。

Offshore Chinese market registered a negative return in October, ongoing trade tension, rising yields and concerns over economic growth have all led to broad sell-off across major markets. Hong Kong market performed in line with China market registered a negative return. Defensive stocks including telecommunication operators and utilities companies continued to outperform. The US equity market declined as technology shares fell out of favour and markets grew concerned about US-China trade tensions. European equities fell with backdrop concerns around geopolitical factors such as Brexit and the escalating trade war between the US and China continued. Japan equities also fell sharply as the risk of a global economic downturn increased and the deterioration in investor sentiment. ASEAN equity markets declined less, Philippines and Indonesia among the best performers in the region. In October, government bonds outperformed corporate bonds with investment grade in turn outperforming high yield bonds.
