- 景順強積金策略計劃(「本計劃」)現提供預設投資策略及十二項成分基金，包含以下基金類別：股票基金(包括緊貼指數基金)、債券基金、貨幣市場基金、回報保證基金與混合資產基金。
- 所有於「每月基金便覽」內呈列的資料均屬於成分基金之資料。

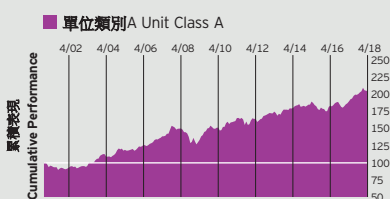

基金評論 Fund Commentary

4 月份，離岸中國股市於月內輕微變動，MSCI 中國指數 4 月份收市價跟 3 月底保持不變。中美之間的貿易緊張局勢及有關國內改革以及開放舉措的消息令投資者情緒受壓，導致市場持續波動。4 月份，香港股票上升。經濟方面，受本地開支平穩及入境旅遊增長的支持，零售銷售額維持穩健增長。隨著貿易緊張局勢有緩解跡象，市場轉而關注業績期企業盈利，美國股市幾乎收復年內跌幅，並於 4 月微升。歐洲股市錄得年初至今的最高單月回報。企業盈利數據穩健，推動歐洲股市走高。避險情緒回落、商品價格上漲和通脹預期升溫，帶動政府債券孳息於 4 月上升。因此高收益企業債券於債市的表現最佳。有關美中貿易戰的憂慮有所舒緩推動投資者風險胃納增加。10 年期美國國庫券孳息突破 3% 的心理關口。

Offshore Chinese equities equities marginally moved in April with MSCI China index closed unchanged from March end. A mix of headlines surrounding trade tensions with the US and announcements of domestic reform and opening-up measures weighted on investor sentiments and continued to result in market fluctuations. Hong Kong equities rose in April. On the economic front, retail sales growth remained firm thanks to steady local spending and rising inbound tourism. The US equity market almost erased its losses for the year and made small gains in April amid signs that trade tensions were easing while attention turned to the corporate earnings season. The European equity markets posted their best monthly returns so far, this year. Government bond yields increased amid a decline in risk aversion, rising commodity prices and higher inflation expectations. Against this backdrop, high yield corporate bonds were the best performing area of bond markets. Investors' appetite for risk increased as concerns about a trade war between the US and China eased. The yield of the 10-year US Treasury briefly passed the psychologically important 3% level.
