#### 基金評論 Fund Commentary

鑑於經濟前景不甚明朗且通脹緩和,聯儲局第 三次維持利率不變,有關財政赤字的憂慮及國外 需求減少導致美國國債孳息率全線上升。由於香 港金管局大量注資加上港元需求走弱,港元短期 利率顯著下跌,3個月政府孳息率降至1.42%, 港元兌美元匯率跌1.09%。香港銀行同業拆息 (HIBOR)與聯邦基金利率之間的息差擴大至 1988年以來的最高水平,但這被認為是暫時的, 預期會隨著流動性狀況的變化恢復正常。

The Federal Reserve held rates steady for the third time, citing economic uncertainty and subdued inflation, while US Treasury yields rose across the curve amid concerns over fiscal deficits and reduced foreign demand. HKD short-term interest rates dropped sharply due to a liquidity surge from the Hong Kong Monetary Authority and reduced demand for HKD, with the 3-month government yield falling to 1.42% and the HKD depreciating 1.09% against the USD. The HIBOR-Fed funds rate spread widened to its highest level since 1988, seen as a temporary distortion expected to normalize as liquidity conditions evolve.
