## 基金評論 Fund Commentary

於聯邦公開市場委員會會議上, 聯儲局保持政 策利率不變。1月份,美國整體消費者物價指數 (CPI)按月升0.3%,按年升3.1%。核心CPI按月 升0.4%,按年升3.9%。整體及核心CPI均超出預 期。宏觀數據改善推動美國國債孳息率於2月份 再度攀升。2年期美國國債孳息率升9點子,10年 期美國國債孳息率升7點子,30年期美國國債孳 息率升5點子。香港3年期政府債券孳息率升36點 子,7年期政府債券孳息率升32點子。鑑於融資條 件放寬,前端利率繼續下降。

In the FOMC meeting, the Federal Reserve left the policy rate unchanged. January US headline CPI increased 0.3% MoM and 3.1% YoY. Core CPI rose by 0.4% MoM and 3.9% YoY. Both headline and core CPIs were higher than expected. US Treasury yields moved wider again in February on better macro data. 2yr US Treasury yield rose by 9bps, 10yr US Treasury yield rose by 7bps, and 30yr US Treasury yield rose by 5bps. The HK government bond yield rose by 36bps on the 3yr and 32bps on the 7vr. Front-end rates continued to move lower given the eased funding condition.
