# 什麼是「平均成本法」?

「平均成本法」是一項紀律化的長線投資策略。透過這方式,無論市況如何,您都會以固定的金額作出定期投資於同一個投資項目,例如每月供款\$1,000港元。當價格偏低時,您所投資的固定金額會為您購入較多的基金單位;而當價格偏高時,您則會購入較少的基金單位。長線而言,您的平均投資成本便相對減低。

由於職業退休計劃是以每月供款形式投資,「平均成本法」回報更能反映您的情況,因此 我們為您準備了以上的圖表,以顯示在不同時段的「平均成本法」回報。舉例您在1年前 開始供款,您便可從1年表現一欄找到1年的「平均成本法」回報。

### What is Dollar Cost Averaging?

"Dollar Cost Averaging" ("DCA") is a disciplined approach to long-term investing where you invest a fixed amount of money, for example HK\$1,000 per month regardless of the market situation. With this approach, you therefore buy more units when the prices are low and buy less when the prices are high. Over the long-run, your average investment cost is lowered.

As ORSO is a monthly contribution, the DCA return can therefore better reflect your situation. That's why we have prepared the above table to show you the DCA returns for different time periods. For instance, if you started your contribution to the Scheme one year ago, you may refer to the 1 year performance column for the DCA return.

### Remark:

DCA returns are calculated based on the assumption that a fixed amount of money is invested in the same fund on the last business day of every month. There is no initial transferred-in asset or asset switch during the investment period.

### 基金評論 Fund Commentary

9月份,全球股市表現參差。歐洲、美國及亞洲市 場紛紛於本月收跌。新興市場亦錄得下跌,但表 現優於已發展市場。中國方面,儘管經濟顯現改 善跡象,但房地產板塊表現低迷令投資者情緒受 壓,進而影響中國股市。數據方面,8月份零售銷 售額及工業生產按年增長超出預期。美國聯儲局 選擇保持利率於5.5%不變,與預期基本一致。但 聯儲局暗示有可能於年內繼續加息,同時減少明 年減息次數,由此表達利率可能於「較長時期內 保持高位」的立場。

Global equity markets faced mixed fortunes in September. European, US and Asian markets all ended the month down. Although, losing ground, emerging markets outperformed developed markets. Chinese equity markets were affected by real estate sector woes which weighed on investor sentiment - despite signs of an improvement in the economy. On the data front, retail sales and industrial production year-on-year (YoY) for August came in above expectations. The US Federal Reserve (Fed) opted to hold interest rates at 5.5%. This was broadly in line with expectations, but the Fed signalled that more interest rate hikes are likely to come this year with fewer cuts next year feeding into the 'higher for longer" mantra.



The Federal Open Market Committee maintained the US fed funds rate but revised its dot plot chart eliminating two anticipated interest rate cuts for 2024. The European Central Bank raised its key rate to 4% but suggested it might be the last increase. Corporate bonds saw mixed performance, with high yield outperforming investment grade bonds. US high-quality bonds and Euro investment grade bonds weakened, while Sterling Corporate bonds gained.


於9月份召開的聯邦公開市場委員會會議上,聯 儲局保持政策利率不變。聯儲局預計,未來兩年 的國內生產總值(GDP)增長將遠遠超出6月份的 估計,失業率則將較估計為低。整體消費者物價 指數(CPI)按月升0.6%,錄得自2023年以來的最 大月升幅。整體通脹按年增長3.7%。核心CPI按 月及按年升幅分別為0.3%及4.3%。9月份,美國 國債孳息率曲線進一步趨向熊市走峭。2年期國 債孳息率升20點子,10年期國債孳息率則飆升 逾45點子。30年期國債孳息率激增約50點子。 香港3年期政府債券孳息率升23點子,7年期政 府債券孳息率升28點子。9月份,短期利率升近 200點子。

In the September FOMC meeting, the Fed kept the policy rate unchanged. The Fed predicted much higher real GDP growth and lower unemployment rate in the next 2 years compared to June estimates. The headline CPI rose by 0.6% MoM, posting the biggest monthly gain of 2023. The YoY increase in headline inflation was at 3.7%. The core CPI increased 0.3% MoM and 4.3% YoY. US Treasury yield curve further bear steepened in September. 2yr yield was higher by 20bps while 10yr yield rose sharply by more than 45bps. 30yr yield also rose sharply by around 50bps. The HK government bond yield rose by 23bps on the 3yr and 28bps on the 7yr. Front-end rates were squeezed higher by almost 200bps in September.
