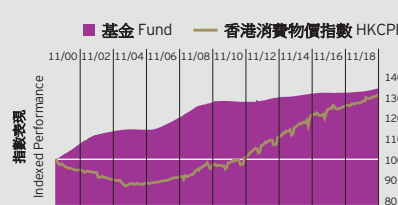

基金評論 Fund Commentary

美國中期選舉結果顯示，民主黨取得眾議院控制權，而共和黨則維持對參議院的控制，令國會陷於分裂。貿易談判繼續成為11月份的主導因素，因為市場等待特朗普與習近平在20國集團峰會上就可能的貿易協定舉行會談。聯儲局在11月公開市場委員會會議上維持利率不變。市場認為聯儲局主席鮑威爾和副主席克萊里達的最新言論屬於溫和。美國國債孳息曲線趨於平坦看漲。10年期美國國債孳息率下跌16個基點，從3.15%回落至2.99%，而兩年期僅下跌10個基點。隨著銀行開始籌集年底和農曆新年的資金，流動性亦隨之收緊。短期香港銀行同業拆息受擠壓，1個月利率上升至2%或以上。

The US mid-term election results pointed to a gridlocked congress with Democrats taking control of the House and Republicans retaining control of Senate. Trade talks continued to be dominant factor in November, as the market awaited a meeting between President Trump and Xi at the G20 summit for a possible trade agreement. The Fed left rates unchanged at the November the Federal Open Market Committee (FOMC) meeting. Fed Chair Powell and vice-Chair Clarida's latest comments were taken as dovish. Treasury curve bullish flattened. 10YR Treasury yields down 16bps, retraced back to 2.99% from 3.15%, while 2YR only dropped 10bps. Liquidity tightened as banks started preparing funding for year-end and Chinese New Year. Short-term HIBORs got squeezed, 1-month rate traded to 2% or above.
