Introduction

- EVC Platform is launched on 22nd May 2023 to allow HAPFS eligible members to first-time enroll employee voluntary contribution ("EVC"), input contribution percentage, and initial fund choices.
- You can access to the EVC Platform by going to the HAPFS website under the HA HR Intranet (<u>http://hapfs.home</u>), clicking Member Login, and then clicking the EVC Platform.
- Please note that you CANNOT access the EVC Platform by other means such as HA mobile app.
- Once the instruction is submitted, you can only change your contribution percentage when the platform is open next year.
